RULES & REGULATIONS FOR NIRMAN - 2013

1. Participants shall have to collect their registration badges latest by 17-10-2013.
2. In case of any dispute, the decision of the exhibition Management committee of THE GUJARAT INSTITUTE OF CIVIL ENGINEERS AND ARCHITECTS shall be final and binding to the participants.
3. All verbal agreements, permission, approvals or special authorization shall be valid only if written confirmation is obtained from GICEA authorities.
4. The organizers will do their best to ensure the supply of various services agreed to but they shall not incur any liability to the participants for any loss, damage that may occur due to partial or total failure of such services.
5. Under the condition of force majeure which shall also include riot, strike, lockout, closure and any man-made or natural calamities, GICEA reserve the right to alter the dates, duration, cancel, suspend, the whole or in part exhibition or change venue. In such an event, participants is entitled neither to rescind the contract nor to claim any compensation or damages. In case of cancellation of exhibition of stall, rental paid in part or full will be not be refunded to the participants by GICEA.
6. All dispute will be subject to Ahmedabad Jurisdiction.
7. The participants shall have to abide by general rules of exhibition for safety, maintenance and use as enforced by the Concerned authorities.
8. Participants are advised to insure exhibits and display materials against any type of loss, manmade, fire, flood, rains, theft and any other reason whatsoever. It would also be advisable to obtain third party insurance for the period of exhibition.
9. GICEA will make the general security arrangements. However, participants shall be responsible for the security of their exhibits and stall. They shall make security arrangements through Security Agencies approved by the GICEA only.
10. Organizers (GICEA) reserve the right to change size, alter location, orientation & layout of stalls.
11. Canteen facility shall be provided where soft drinks and snacks and high tea shall be available at reasonable prices. Cold water shall be available at free of cost as decided by GICEA.
